Dr. Moon has been the director of Oil Policy Research Division of Korea Energy Economics Institute since Oct. 2013, having been Senior Research Fellow from 1997. He was born in 1959 in Korea and educated at State University of New York at Buffalo in USA, obtaining an MA in Economics in 1988 and a PhD in 1990 respectively. For 22 years (1992-2014), he was a research fellow at KEEI, where he also served as Vice President, Managing Director of the Energy Policy Research Group, Department of Research Coordination and Planning, and Department of Energy Industry Studies.

His main research fields are oil & gas industries and advising Korean government to set up general energy policy directions. Recently, he was the project manager of "Enactment of Basic Energy law" and "The Second National Energy Plan" sponsored by Ministry of Trade, Industry and Energy of Korea
